5. Sealed Bids must be submitted to the Nepal Rastra Bank, Nepalgunj Office, Dhambojhi, Banke by hand/courier or before 12:00 Noon on 2080/01/28 B.S. Bids received after this deadline shall not be accepted.
6. The Bid will be opened in the presence of Bidder's authorized representatives who choose to attend at 12:30 P.M. on 2080/01/28 B.S. at the Nepal Rastra Bank, Nepalgunj Office, Dhambojhi, Banke. Bids must be valid for a period of 90 days counting from the bid opening and must be accompanied by bid security, which shall be valid for minimum 30 days beyond the bid validity period (i.e., 2080/05/21 B.S.).
