Nepal Rastra Bank, Birgunj Office invites sealed bids from eligible bidders for the **Main Building, Staff Quarter, Guard Quarter, Guest House & Guest House Boundary Wall Painting Works** under National Competitive Bidding procedures. Only eligible bidders as per **Public Procurement Act 2063 and NRB Procurement Bylaw 2071** should participate in this bidding. The estimated cost for the work is **Rs.46,53,703.35 (Including VAT)**.

A complete set of Bidding Documents may be purchased from the office of Nepal Rastra Bank, **Birgunj Office, Internal Administration Section** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of **Rs.3,000.00** till 2076/02/07. If so requested, the Bidding Documents can also be sent by post/courier services upon payment of additional courier charges. However, the Employer will not be responsible for delay or non-delivery of the documents so sent.
4. Sealed bids must be submitted to the office Nepal Rastra Bank, **Birgunj Office** by hand/courier on or before 12:00 Noon on 2076/02/08. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' authorized representatives who choose to attend at 12:30 PM on 2076/02/08 at the office of Nepal Rastra Bank, **Birgunj Office**. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security amount of **Rs.1,35,000.00 (In Words Rupees One Lakh Thirty-five Thousand Only)** which shall be valid for 30 days beyond the validity period of the bid (i.e.2076/06/30) or cash voucher deposited on Sundry Creditor's A/C (A/C no 1709999/011-000-524) of Nepal Rastra Bank, Birgunj Office.
6. If the last date of purchasing and /or submission falls on a public holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
7. Nepal Rastra Bank reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
