3. Bidders shall submit their bid electronically and may download the bidding documents for e-submission from PPMO's web site www.bolpatra.gov.np/egp. Bidders should deposit the bidding Document Fee in the account as specified below and the scanned copy (.pdf format) of the Bank Deposit Voucher should be uploaded at the time of electronic submission of the bid.

4. Electronic bids must be submitted to the **Nepal Rastra Bank, General Service Department, Baluwatar, Kathmandu, Nepal** through PPMO website www.bolpatra.gov.np/egp on or before 12:00 hours on 2075/07/28. Bids received after this deadline shall not be accepted.
5. The bid will be opened in the presence of Bidders' authorized representatives who choose to attend at 12:30 hours (for hatchback/CUV car bid will be open at 14:30 hours) on 2075/07/28 at the Nepal Rastra Bank, *General Services Department, Baluwatar, Kathmandu, Nepal*. However, the absence of bidder or its authorized representatives will not affect the bid opening process.
6. Bids must be valid for a period of **90** days counting from the bid submission deadline and must be accompanied by bid security amount as specified at point (1) above and it shall be **valid for minimum 30 days** beyond the bid validity period i.e. 2075/11/30. If bidder wishes to submit bid security in the form of cash, the cash should be deposited in the following account:
