1. **Nepal Rastra Bank** has allocated funds towards the cost of **Construction of Physical Infrastructures of Nepal Rastra Bank at Sanothimi, Bhaktapur** and intends to apply part of the funds to cover eligible payments under the Contract **for Construction of Physical Infrastructures of Nepal Rastra Bank at Sanothimi, Bhaktapur Contract ID No.: NRB/Works/NCB/01/079/80**. Bidding is open to all eligible as per Section V of bidding document.
2. **Nepal Rastra Bank** invites electronic bids from eligible bidders for the **construction of Physical Infrastructures of Nepal Rastra Bank at Sanothimi, Bhaktapur** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs.1,062,435,000**.
 - Minimum Work experience of similar size and nature: **Participation as Prime contractor, management contractor, or subcontractor, in at least One (1) Contract within the last ten (10) years, with a value of at least NRs. 849,948,000 that have been successfully or are substantially completed and that are similar to the proposed works. The similarity shall be based on the physical size, complexity, methods, technology or other characteristics as described in Section VI, Works Requirements.**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

5. Bidder who chooses to submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document (**NRs. 20,000**) in the account as specified below .

6. Pre-bid meeting shall be held at **Nepal Rastra Bank, Assets and Service Management Department, Baluwatar, Kathmandu at 12:00 PM on 2079/09/14**.
7. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 PM on 2079/09/24**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 on 2079/09/24** at the office of **Nepal Rastra Bank, Assets and Service Management Department, Baluwatar, Kathmandu**. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 38,000,000**, which shall be valid for 30 days beyond the validity period of the bid (*i.e. 2080/02/24*).
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
