Invitation for Bids for the: **Construction of Physical Infrastructures at Sanothimi, Madhyapur Thimi, Bhaktapur**

- Nepal Rastra Bank, General Services Department, Baluwatar, Kathmandu** invites electronic bids from eligible bidders for the **Construction of Physical Infrastructures at Sanothimi, Madhyapur Thimi, Bhaktapur** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:
  - Minimum Average Annual Construction Turnover of the best three (3) years within the last ten (10) years: **NRs 480,000,000 without VAT.**
  - Minimum experience under construction contracts: **Five (5) years prior to the applications submission deadline**
  - Minimum Work experience of similar size and nature: **Three (3) residential or commercial buildings within the last ten (10) years, each with a value of at least NRs 650,000,000 without VAT**
  - Construction Experience in Key Activities: **RCC work of at least 5,000m<sup>3</sup>, Brick masonry wall works of at least 4,000m<sup>3</sup> and Stone masonry works at least 3,000m<sup>3</sup>**
- Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate bids, one (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 21 of the Bidding Document.
- Eligible Bidders may obtain further information and inspect the Bidding Documents at PPMO e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp).
- Bidder shall download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit nonrefundable cost of bidding document Rs.20,000 in the account as specified below.

- Pre-bid meeting shall be held at Nepal Rastra Bank General Services Department, Baluwatar, Kathmandu at 2076/04/20.
- Electronic bids must be submitted through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00 Noon** on 2076/05/01.
- The bids will be opened in the presence of Bidders' authorized representative who choose to attend at 12:30 P.M. on 2076/05/01 at the Nepal Rastra Bank General Services Department, Baluwatar, Kathmandu. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a scanned copy of the bid security in .pdf format, amounting to a minimum to **Rs 25,000,000 ( In Words: Rs Twenty Five Million Only)**, which shall be valid for 30 days beyond the validity period of the bid (i.e. 2076/09/29)
- If the last date of submission falls on a public holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- Nepal Rastra Bank reserves the right to accept or reject any bid, and to annul the bidding process and reject all Bids at any time prior to contract award, without thereby incurring any liability to Bidders.
