1. The **Nepal Rastra Bank** invites **electronic** bids from eligible bidders for the procurement of **Supply, Delivery, Installation, Testing and Commissioning of Furniture, AV System, Vault Storage and Security System, Interior Items including Incidental Services for the Newly Construction Office Building at Thapathali, Kathmandu** under National competitive bidding – Single Stage Two Envelope procedures.
2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 23 of the Bidding Document.
3. 4. Bidder submitting their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost of bidding document NRs. 20,000.00 in the following account as specified below.

5. Pre-bid meeting shall be held at **Nepal Rastra Bank, Thapathali building construction site, Thapathali, Kathmandu** at **2079/09/24 11:00 AM**.
6. Electronic bids must be submitted through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) **on or before 12:00 Noon on 2079/10/09**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00** on **2079/10/09** at the office of **Nepal Rastra Bank, Assets and Service Management Department, Baluwatar, Kathmandu**. Bids must be valid for a period of **120 days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **11,500,000**, which shall be valid for 30 days beyond the validity period of the bid (i.e. **2080/03/07**).
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
