5. Quotations must be valid for a period of **45 days** from the last date of submission of Sealed quotations and must be accompanied by Cash Security or Bank Guarantee, amounting to NRs **60,000.00** which shall be **valid for 75 days** from the last date of submission of Sealed Quotations.
6. If bidder wishes to submit the Cash Security, the cash should be deposited in Sundry Creditors Account No. **1809999/011/001/524** at Nepal Rastra Bank, **Pokhara Office, Rastra Bank Chowk, Pokhara, Kaski** and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
