4. Sealed Quotation must be submitted to the Nepal Rastra Bank (NRB), Financial Information Unit, Baluwatar by hand on or before 12:00 Noon on 2078/05/14. Sealed Quotations received after this deadline will be rejected.
5. Sealed Quotations will be opened in the presence of Suppliers' representatives who choose to attend at 12:30 PM on 2078/05/14 at the Nepal Rastra Bank, Financial Information Unit, Baluwatar.
6. Sealed Quotations must be valid for a period of **45 days** after bid opening and must be accompanied by a bid security amount mentioned above in table.
7. Bid security shall be valid for **30 days** beyond the validity period of the bid.
8. If bidder wishes to submit the Cash Security, the cash should be deposited in **Sundry Creditors Account Number: 2409901/011/000/524 at Nepal Rastra Bank, Banking Office, Baluwatar** and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
