5. Quotations must be valid for a period of **45 days** from the last date of submission of Sealed Quotations and must be accompanied by Cash Security or Bank Guarantee mentioned above which shall be **valid for 75 days** from the last date of submission of Sealed Quotations.
6. If bidder wishes to submit the Cash Security, the cash should be deposited in Sundry Creditors Account No 2109999/011/002/524 at Nepal Rastra Bank, Nepalgunj Office, Banke and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
7. Sealed Quotation shall be opened in the presence of supplier's authorized representative who chooses to attend at 2:00 PM on 2075/08/24 at the Nepal Rastra Bank, Nepalgunj Office, Banke.
