2. Bidder can bid for any category or any number of categories or all of the categories of goods mentioned at the point 1 above, however, the bid security amount depends upon the number of categories.

(For example: for category A the security amount will be Rs.285,000 and for category A and B the bid security amount will be Rs 369,000. Similary for the category A, D and G the bid amount will be Rs. 8,68,830 and for all



categories A to G, the bid amount will be Rs.13,27,830. The bidder will be assessed for technical, price & financial aspect on the basis of individual category of item.

- 3. Bidder bidding for Categories B, F & G should bid all items within the particular category. For example for category B the bidder should bid for B1 and B2. Bidding only in B1 is invalid. Similarly, for G the bidder should apply for all items within the category G i.e. G1, G2, G3 & G4. Bidding only G1 or G1 and G2 or GI, G2 and G3 is invalid.
- 4. Eligible Bidders may obtain further information and inspect the bidding documents at Nepal Rastra Bank, *General Services Department, Baluwatar, Kathmandu, Nepal* or may visit **Public Procurement Monitoring Office (PPMO)** website at www.bolpatra.gov.np/egp;
- 5. Bidder shall submit their bid electronically and may download the bidding documents for e-submission from PPMO's web Site www.bolpatra.gov.np/egp. Bidders should deposit the cost of bidding document in the account as specified below and the scanned copy (.pdf format) of the Bank deposit voucher shall be uploaded at the time of electronic submission of the bid. - 7. The Bid will be opened in the presence of Bidders' authorized representatives who choose to attend at 12:30 hours on 2075/06/18 at the Nepal Rastra Bank, *General Services Department, Baluwatar, Kathmandu, Nepal.* However, the absence of bidder or its authorized representatives will not affect the bid opening process.
