A complete set of Bidding Documents may be purchased from Nepal Rastra Bank, Assets and Service Management Department, Baluwatar, Kathmandu by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of Rs. 1,000 till 2078/03/10 during office hour.
4. Bidder who chooses to submit their bid electronically may download the bidding documents for e-submission from PPMO's WebSite [www.bolpatra.gov.np](http://www.bolpatra.gov.np). Bidders, submitting their bid electronically, should deposit the non-refundable cost of bidding document NRs. 1,000 (One Thousand Only) in the account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

Sealed bids must be submitted to the Nepal Rastra Bank, Assets and Service Management Department, Baluwatar, Kathmandu by hand or through e-GP system i.e. [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 Noon on 2078/03/11. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' authorized representatives who choose to attend at 1:00 P.M. on 2078/03/11 at Nepal Rastra Bank, Assets and Service Management Department, Baluwatar, Kathmandu. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to Rs. 35,000, which shall be valid for 30 days beyond the validity period of the bid (i.e. 2078/05/23).
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. Nepal Rastra Bank reserves the right to accept or reject, wholly or partly any or all the Sealed Quotations without assigning any reason, whatsoever.
9. Provided that all sealed bids submitted before this re-invitation shall stand cancelled and are encouraged to rebid if they intend to take part in the sealed bidding process.
