A complete set of Bidding Documents may be purchased from the office of ***Nepal Rastra Bank, General Services Department, Baluwatar, Kathmandu, Nepal*** or ***Nepal Rastra Bank, Banking Office, Thapathali, Kathmandu, Nepal*** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of Rs. 3,000.00 [***NRs Three Thousand Only***] till 2075/07/04.
4. Pre-bid meeting shall be held at ***Nepal Rastra Bank, General Services Department, Baluwatar, Kathmandu, Nepal*** at 11:00 am on 2075/06/22.
5. Sealed bids must be submitted to the office of ***Nepal Rastra Bank, General Services Department, Baluwatar, Kathmandu, Nepal*** by hand/courier on or before 12:00 Noon on 2075/07/05. Bids received after this deadline will be rejected.
6. The submitted bids will be opened in the presence of Bidders' authorized representative who choose to attend at 12:30 PM on 2075/07/05 at the office of ***Nepal Rastra Bank, General Services Department, Baluwatar, Kathmandu, Nepal***. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security, amounting to Rs. 1,19,000.00 (NRs One Lakh Nineteen Thousand Only) which shall be valid for 30 days beyond the validity period of the bid (i.e. 2075/11/07)
7. If the last date of purchasing and /or submission falls on a public holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission
8. Nepal Rastra Bank reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
