- Electronic bids must be submitted to Nepal Rastra Bank, Mint Division Babarmahal, Kathmandu through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 Hours on 2081/12/13. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 12:30 Hours on 2081/12/13 at the office of Nepal Rastra Bank, Mint Division, Babarmahal, Kathmandu. Bids must be valid for a period of 90 days from the date of bid opening i.e, 2082/03/10 and must be accompanied by a scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs.1,48,000/-, which shall be valid for 30 days beyond the validity period of the bid (i.e. 2082/04/09).
