AML/CFT Program on Nepal's Overall Status

Excellencies and development partners
Secretaries and other high level officials of various entities of Nepal
Head of the Legal Department of IMF and his team
Nepalese Officials,
Organizers,
Ladies and Gentlemen,

It is my pleasure to be present here and deliver concluding remarks at the completion of 6th year of Nepal-IMF cooperation on AML/CFT. This partnership has been of substantial value to Nepal. We have arrived at a stage of sound AML/CFT legal, regulatory and enforcement framework as well as have come out of the FATF monitoring process. These developments have provided us a solid foundation to better face challenges in a judicious manner. The credit of this achievement primarily goes to our internal team, IMF and development partners.

The long term benefits for financial transparency and integrity to the economy that is drawn from AML/CFT implementation is immeasurable. It is more relevant for a developing country like Nepal where overall controlling measures are in developing stage.

AML/CFT is a dynamic and complex regime. Compliance of the revised FATF standards and assessment under new methodology with focus on implementation and effectiveness is a serious challenge to all of us. It has been reported to me that the cooperation from the experts of IMF mission is of excellent and superb quality. The developed laws, rules, regulations, strategy, manuals, etc have been tested and proved exemplary not only in Nepal but also in other parts of the world. We are sincerely grateful to IMF and particularly the Senior Counsel and Head of Capacity Development Unit, Mr. Mathew Byrne and Project Manager Ms Cecilia Marian for their contribution and effort in this regard.

As the mission concludes, I believe, the supports that IMF has contributed to strengthening our system and making it more effective and efficient. In this context, I would like to extend our warm appreciation and sincere thanks to the member of IMF mission and development partners. It is indeed a cornerstone in our capacity building process. We look forward to strengthening such cooperation in the days to come.

At the end, by requesting all our agencies to focus on the use of the tools developed, I would like to stress upon that it is not an ending but a great beginning for forever. Hope you have a good stay in Nepal.
